R01	Maintenance and remedial work records	Supplied by contractor
R02	Written scheme of examination	Drawn up by a competent person and copy kept on site
R03	Thorough inspection records—usually 6 months for roof safety equipment	Task record. Sometimes completed during ‘insurance inspections.’

## Lifts and lifting equipment

Section/ Doc Ref	Document name	Information
L01	Logbook for all lifting equipment, including personnel lifts, hoists and platform lifts	Record of installation, location, maintenance, incidents, remedial works. School document.
L02	Maintenance and remedial work records for all of the above	Supplied by contractor.
L03	Written scheme(s) of examination	Drawn up by a competent person and copy kept on site
L04	Thorough inspection records - usually six monthly for people carrying equipment	Sometimes completed during ‘insurance inspections.’ Contractor document.
