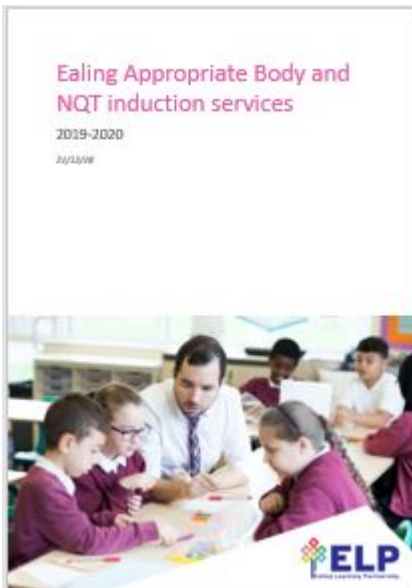

Additional charges

There are additional charges where a school wishes to:

- Reduce the length of induction for an NQT
- Extend the induction period for an NQT
- Determine completion of induction year and exemption from induction year (eg in the absence of relevant paperwork)
- Request additional bespoke consultancy and support relating to the induction year

More detailed information:

As Appropriate Body Ealing will:

- deliver its statutory duties as the AB
- register NQTs with the AB and the Teacher Regulation Agency (TRA) and inform the school if the NQT has not been registered correctly
- read/review and quality assure assessment reports every term
- make the final decision on whether the NQT's performance against the relevant standards is satisfactory or whether an extension is required and notifies TRA
- carry out quality assurance visits and document sampling with at least 10% of schools and colleges registered with Ealing AB
- liaise with schools and provide relevant information and advice on NQT induction procedures, statutory guidance and NQTs causing concern, including up to 2 school visits if necessary
- maintain records and assessment reports online and support schools and colleges with the secure online system 'NQT Manager' for 6 years
