Schools Research and Data Team

The Schools Research and Data Team continue to provide a variety of services concerning the collection, analysis, and reporting of a range of data including school and pupil performance, inclusion, SEND, Virtual School, and school place planning data.

We have recently had two new members of the team join us:

- Emma Chapman – Performance and Data Analyst (SEND) joined us at the end of August,
- Shane Ryan – Senior Performance and Data Analyst joined us at the end of October.

Finally, Jen will be moving to part time working during November (3 days per week).

The team remains hybrid, with regular in-the-office days. Autumn school census 2023

At the time of writing, all Ealing LA maintained schools have submitted their autumn census return, we appreciate your ongoing cooperation and responsiveness in resolving errors, queries and duplicates. For those academies and free schools who are yet to submit, the deadline for academy submissions has passed (Wednesday 1st November), the COLLECT database closes for amendments on Wednesday 29th November.

Spring school census 2024

Spring 2024 school census day is Thursday 18th January 2024. As usual the local authority ask that schools submit their return by Friday 19th January and notify us if there is likely to be a delay beyond this in making your return.

School workforce census 2023

School workforce census was Thursday 2nd November 2023. As usual we asked LA maintained schools to submit by Friday 3 November. Remember all errors and queries in COLLECT need to be

addressed before the local authority can approve your return. It is also important to ensure that you have checked all the reports on COLLECT to make sure the data you have submitted is correct.

School workforce is a statutory return. Data from the return is published at school level on the DfE's explore education statistics and GIAS websites, and in your IDSR, so it is important that you check your submission thoroughly for accuracy. This year it will also serve as the funding basis for the new Early Careers Framework.

Children in part time or alternative provision

The schools data team are no longer collecting the children in part time or alternative provision biannual data return. Schools are now asked to submit this data on a referral basis via gateway. School reports on the EGfL

For **ELP Schools** (or schools who buy directly into the data team service): Updated NEET churn reports were made available via the school reports section of your school's page of the EGFL in the summer.

Updated initial RON lists, showing pupils in your new year 7 intake who might potentially be at risk of NEET when they leave high school (based on Ealing's RONI factors) will be added in the next few weeks.

We are currently working on your GCSE / Key Stage 4 attainment reports and will have them with you before the end of November. We haven't yet received Key Stage 5 data from the DfE, but would hope to have it sometime in November and your attainment reports to you toward the end of term.

Summaries of attainment and attendance for children with a social worker, children with SEN, and Black Caribbean and Somali pupils, have also been made available - or will be updated shortly.

Secondary attendance benchmark reports and school place planning reports were published for schools in October.

Additional Support for Schools

We offer a tailored service to schools through buy-back. Schools can book a member of our team to come into school and talk to data managers, senior management, classroom teachers, and/or governors about their school's data. This can include using performance data; and/or improving pupil tracking and information management. Schools can also commission the Research and Data Team to undertake additional analysis or training above and beyond that currently offered.

This buy back service is available for 2023/24 at a cost of £350 per half day (£450 non ELP schools) (or on a pro rata basis), subject to availability and capacity, and can be booked by contacting Jen.
