## Where does school census data go?

A summary of funding and published data which is based on schools' termly school census returns.

For those of us who work on school census, we all know it is a statutory (lawful) requirement for schools to complete once a term. But why do we spend so much time working on it, and why is it important that the data is as accurate and complete as possible?

There are three main strands to where your school census data goes:

- 1. Funding direct to schools based-on school census data items,
- 2. Funding to local authority which drives funding available to schools for high needs and early years,
- 3. Published data.

Additionally, the DfE have been known to retrospectively use previously collected data, or decide at the last minute to use different data collections to inform additional funding streams – particularly during COVID. So, whilst it is important to make sure all the following data items are correct, all the data you submit in census should be accurate and up to date.

The COLLECT system which schools use to submit their school census return to the DfE does some basic data checking on these data items, but it is limited. Ealing local authority do comprehensive data checks, which is why we ask that all schools (including academies) submit their census return the first Friday following each school census day, in order to give us enough time to check this data for you.
