

The DfE's alternative to commercial insurance

RPA is the Department for Education's alternative to commercial insurance cover for schools and academies.

The RPA was introduced in 2014 and to date over two thirds of academies have joined and benefit from reduced costs and avoid the administrative burden of securing their risk protection.

As of April 2020, Local Authority Maintained Schools can now also benefit from joining the RPA.

Ready to join?

Joining is simple and takes less than 5 minutes. There are no forms and RPA operates on a no material fact disclosure basis therefore we don't need estate/buildings/contents valuations or review your schools risk rating.

For academies, Education and Skills Funding Agency (ESFA) will deduct £18 per pupil (per place in special and Alternative Provision academies) from an academy's General Annual Grant (GAG).

For local authority maintained schools, an £18 per pupil deduction will be made to the local authority's Dedicated Schools Grant (DSG).

RPA pricing is subject to annual review.
