EALING 'SUPPORTING PUPILS AT SCHOOL WITH MEDICAL CONDITIONS' WORKING GROUP, NOVEMBER 2017

Purpose

The main objective is to produce a medical conditions policy for Ealing schools to adopt, based on DFE guidance, and tailored according to the local situation.

This will enable:

- Consistency/standardisation of medical conditions policies in Ealing schools
- Clarity around roles and responsibilities
- Clarity around individual healthcare plans
- Clarity around expectations of training
- Updating of the existing 'managing medicines in schools' document, to include recent legislative changes such as the use of spare adrenaline auto-injectors in schools.

Other outputs will include guidance on implementation of the policy, updating the Ealing Grid for Learning (EGFL) website¹ and production of a promotional infographic for schools.

Context

Since the Children and Families Act in 2014 schools² have had a statutory duty to make arrangements to support pupils with medical conditions at school, and in doing so, adhere to guidance published by the Department for Education (DFE) in 2015.³ However, there is evidence of poor implementation of this duty and adherence to the related DFE guidance. In early 2017 the Health Conditions in Schools Alliance conducted a survey of 200 schools in England, and only 11.5% of these schools demonstrated that they had an adequate medical conditions policy that followed statutory guidelines.⁴

The local situation in Ealing mirrors this, with many schools not having an accessible medical conditions policy on their website, and the content of each policy is variable.

The context for the formation of this multi-agency working group in November 2017 is a recognition of the need to support schools to meet this duty, especially in light of the two tragic deaths in Ealing schools in 2016/17 and increasing staff concerns over roles and responsibilities. This is also against a backdrop of financial pressures for schools, the local authority and the NHS, including a reduced capacity of the school nursing service.

Meetings

The wider group will convene twice between November 2017 and February 2018. The core group may have additional meetings between this time to produce the policy document.

All members are required to prepare as necessary in advance of meetings and proactively contribute to activities according to their knowledge and skills.
