Department for Education (DfE)

30 hours Childcare Entitlement

In June 2015, the government introduced the Childcare Bill to bring in 30 hours of free childcare for employed families of 3 and 4 year olds.

The childcare expansion will be rolled out nationally in 2017, <u>with early implementation in some</u> <u>areas</u> to begin in September 2016. Paediatric First Aid

Paediatric first aid requirements in the statutory framework for the early years foundation stage: government response

Following a review of the consultation results regarding paediatric first aid requirements set out in the EYFS, the Government will proceed with requirements for additional staff to be trained- "...from 1 September 2016, a requirement in the EYFS that for newly qualified early years staff (with full and relevant level 2 or level 3 childcare qualification) to also hold a current Paediatric First Aid (PFA) or emergency PFA certificate in order to be included in the required staff: child ratios in an early years setting. Childcare providers will be allowed a three month 'grace' period to complete PFA training after starting work with a new employer." Subject to Parliamentary approval, regulations will be in force form September 2016, with the EYFS being revised to reflect this."

<u>DfE have provided clarification</u> on the meaning of prescribed medicines in paragraph 3.45 of the EYFS

Reception Baseline

Reception baseline assessment will not be used as a starting point to measure pupil progress following a comparability study.

The Department for Education has published the <u>results of a study that compares the 3</u> reception baseline assessments used by schools in the 2015 to 2016 academic year. The study concludes that the 3 different assessments are not sufficiently comparable to create a fair starting point from which to measure pupils' progress. As a result, the results cannot be used as the baseline for progress measures, as it would be inappropriate and unfair to schools.

Key stage 1 (KS1) will continue to be used as the starting point from which to measure this year's reception pupils' progress to KS2.

The use of a baseline assessment in the 16/17 academic year is optional, and the outcomes from the assessments will not be used for accountability.

It continues to be good practice for teacher assessment of a child's on entry baseline (using information from their previous setting/home visits/visits to schools/observations in the first few weeks of school), though this can be a school based decision

Standards & Testing Agency

Early Years Foundation Stage Profile (EYFSP)

The early years foundation stage profile will remain statutory for the 2016 to 2017 academic year

The Standards and Testing Agency have communicated with operational leads in schools and local authorities to confirm that the EYFSP will remain statutory for the 2016 to 2017 academic year. The Secretary of State for Education, Justine Greening, has just announced that the EYFSP will also remain in place for the 2017 to 2018 academic year. Schools must complete the EYFSP for reception pupils by 30th June 2017 and report results to the local authority

EYFSP results for the 2015 to 2016 academic year have been published

Electrical socket covers

The Department of Health are instructing Health and Social Care settings to stop using socket covers/inserts due to safety issues, by the 1st December 2016. Read the alert <u>here</u>

The Department for Education advises: Although it is not illegal to use electrical safety socket covers, the DfE recommends that providers should take into account the advice included in this alert when carrying out their own risk assessment.
