Our celebration this term is that Early Years Foundation Stage Profile Outcomes 2016/2107 show we have made a big difference to children in Ealing, with a marked improvement in school readiness at the end of Reception. **71.6%** of children achieved a **good level of development** (GLD). This is in comparison to 69.4% in 15/16. Children eligible for Free School Meals (FSM) also continue to have a strong start in Ealing with 62% achieving a GLD, which is above national comparison (England 2017 – 56% GLD for children eligible for FSM). The work in Ealing early year's settings continues to make a significant impact in helping to raise children's attainment.

Published in December 17, the report examines the quality of schools and early years, and highlights that early years providers on the Early Years Register judged as being Outstanding or Good has increased from 74% in 2012 to 94% in 2017

Self-evaluation and the Ofsted SEF

As you may have been made aware through managers and childminder briefings, from the 1st April 2018 Ofsted will no longer be providing a template to record self-evaluation, neither the word version nor the online tool. However, the expectation to continue to evaluate the effectiveness of your provision remains.

Self-evaluation is an ongoing process which involves reviewing the quality and effectiveness of your provision relating to the care and activities provided and how well you are meeting the learning needs of all children, and identifying what needs to improve. Self evaluation should include the views of parents and evaluate the progress made by all children.

The Ofsted SEF template has always been an optional tool on which to record self-evaluation. The removal of the template encourages settings to take ownership of their own self-evaluation processes and to develop their own tools which best reflect and meet the needs of individual providers and settings

Early Years Quality Services 18-19

We are excited to be developing the Ealing Early Years Quality Consultancy to provide expert practical support and challenge to continue to improve outcomes and narrow the achievement gap for children in Ealing.

We have been listening to your views and feedback and have been consulting with early years providers in Ealing through a range of activities including an online survey, focus groups and through managers briefings and childminder network meetings. This feedback will help us to shape our services to ensure we continue to meet the needs of a range of early years providers

Consultation activities have revealed that while the principle of buy-back was largely endorsed, finance will be a barrier to most early years providers. The LA have therefore agreed to support part-funding and we have revised the costings and included some elements at no cost to providers in 2018/19.

At the end of February we will be sharing our brochure with the full detail of our services and packages, and will be sharing regular updates during Ealing manager's briefings and childminder network meetings (dates below)

Early Help Assessment Plan (EHAP)

EHAP training continues to be well attended, with 102 Childcare providers accessing training since February 2016.

To ensure that EHAP continues to be used as an effective process and tool to support children and families through the delivery of multi-agency, multi-disciplinary and targeted support:

- Where there is an additional service/specialist beyond the setting and the family, an EHAP should be initiated to co-ordinate support

- If a child already has several services/specialists involved/another professional refers a child and there is no EHAP, you need to initiate an EHAP to bring these services together
- As well as a referral tool, use EHAP as a working document and central tool for coordinating, planning and regularly reviewing support with parents and professionals
- Remember EHAP is a process with assisting paperwork

Information sharing

Thank you for your transparent partnership working with the Early Years Consultants team and please continue to share any changes/developments at your setting with your EYC which may include risks to quality or Ofsted inspection notification/unannounced visit. This helps the EYC and the LA to respond promptly to needs arising, proactively agree any changes to support and/or be available to speak with Ofsted during your inspection if desired.

Disability Access Fund

The Disability Access Fund (DAF) was introduced in April 2017 to support disabled children's access to the entitlements for three and four year olds. Providers receive £615 per eligible child per year.

Three and four year olds will be eligible for the DAF if they meet the following criteria:

- The child is in receipt of Disability Living Allowance (DLA)
- The child receives the universal 15 hours entitlement
- Please note that children <u>do not have to take up</u> the full 570 hours of early education that they are entitled to in order to receive the DAF. Children will be eligible where they take up any period of free entitlement and receive DLA.
- Four year olds in primary school reception classes are not eligible for DAF funding.

The funds could be used, for example, to support providers in making reasonable adjustments to their settings and/or helping with building capacity, be that for the child in question or for the benefit of children as a whole attending the setting.

Early years providers are responsible for identifying eligible children and are encouraged to use the Department's parent declaration template to do so.
