Why have I been chosen?

As part of this research, we are speaking with individuals who play a role in the supply and provision of school meals. This list includes head teachers, teachers, catering managers and school business managers. You have been selected as you are currently employed in one of these roles within a primary school in Greater London.

What is the project's purpose?

The aim of this study is to understand the approaches schools are taking to implementing LUPFSM. This survey is a key part of the study and aims to collect data from all London primary schools on food meals provisions and practices used to manage food meals. What does the survey involve?

Will taking part be confidential?
